WHEREAS, the Northwest Bergen County Utilities Authority operates a wastewater treatment facility in the Borough of Waldwick, County of Bergen, State of New Jersey; and

WHEREAS, the National Association of Clean Water Agencies (the “NACWA”) is a nationally recognized leader in environmental policy and a well-established technical resource on water quality & ecosystem protection issues; and

WHEREAS, membership in NACWA is a unique opportunity to improve the effectiveness in the operation of the Authority, enhance professional development and achieve the goals & objectives the Authority shares with other publicly owned treatment works; and

**AUTHORIZATION TO INCREASE THE GENERAL COUNSEL BUDGET FOR
BERN ROOT LLC FOR PROFESSIONAL LEGAL SERVICES TO THE

WHEREAS, the law firm of Bern Root LLC, with offices located at 90 West Palisade Avenue, Englewood, New Jersey 07631 is presently providing the Northwest Bergen County Utilities Authority (hereinafter referred to as the “Authority”) with professional legal services, including all matters which, in the opinion of the Executive Director and/or the Commissioners of the Authority shall be referred to General Counsel; and

WHEREAS, by Resolution 24-2022, the Authority previously engaged the services of Bern Root LLC (hereinafter referred to as the “Firm”) to provide various professional legal services as deemed necessary by the Executive Director and/or the Commissioners; and

WHEREAS, the Original Resolution (hereinafter referred to as the “the Original Resolution”) authorized a not-to-exceed cost of \$75,000.00 to be paid to the Firm for their professional legal services in connection with the legal needs of the Authority; and

WHEREAS, the Firm requested an increase to the not-to-exceed cost of the professional legal services by \$50,000.00 related to the position of General Counsel to the Authority for services rendered from October 1, 2022 through February 28, 2023; and

WHEREAS, the Authority’s Certifying Finance Officer has certified that funds are available to accept the proposal.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Northwest Bergen County Utilities Authority the following:

1. The Proposal of Bern Root LLC to provide the additional professional legal services as outlined in the Original Resolution 24-2022 related to required legal services of the Authority in the amount of \$50,000.00 and is hereby accepted, increasing the not-to-exceed cost of legal services to \$125,000.00.
