## MINUTES SPECIAL MEETING – PUBLIC HEARING September 21, 2021

- 1. The Meeting was called to order at 7:16pm.
- 2. The Secretary read the Open Public Meetings Act Statement.
- 3. Roll Call: The following Commissioners were present via a web based conference call on Zoom: Jordan, Kelaher, Lo Iacono, Ortega, Plumley and Chairman Kasparian. Commissioner Bonagura was absent.

Also present on the conference call were Board Secretary Alison Gordon, Executive Director James Rotundo, Assistant Executive Director John Danubio, Municipal Liaison John De Rienzo, General Counsel Douglas Bern, Esq., and Consulting Engineer Nicholas Rotonda. Treasurer Todd Sherer, Authority Engineer Howard Hurwitz and Superintendent Robert Genetelli were absent.

## 4. Chairman's Remarks:

There was a brief discussion concerning the Bonds. The Authority previously authorized Notes for the borrowing of the two projects, the wastewater treatment facility improvements and the improvements of the Authority's gravity interceptor piping system and manholes, specifically rehabilitation of certain sections of the trunk sewer east interceptor and acquisition of certain equipment. The projects have been completed and the funds were received from the New Jersey Infrastructure Bank. Now, the Authority will be converting the loans into Bonds and the Authority will begin paying debt service on these two projects.

5.
