WHEREAS, the municipalities of Allendale, Ho-Ho-Kus, Midland Park, Ramsey,

Waldwick and Wyckoff, on or about March 12, 1965, The Village of Ridgewood on or about

July 5, 1972, and the Township of Mahwah, on or about June 25, 1975, entered into Service

Contracts with the Authority whereby the various rights and obligations of the parties concerning

operation, establishment and calculation of rates, and method of payments were established; and

WHEREAS, on or about July 15, 1986, the Authority adopted a Bond Resolution

authorizing financing for the continued operation and maintenance of the district sewer system;

and

WHEREAS, pursuant to said statutory authorization and Service Contracts, the

Authority adopted a budget for the fiscal year of January 1, 2013 to December 31, 2013, making

provision for the payment of \$13,453,955.00, being the amount that the Authority estimated

would be required (in addition to other funds on hand applicable for such purposes) to be paid by

said municipalities during the current fiscal year January 1, 2013, as and for payment of principal

and interest on outstanding bonds or other obligations authorized by said statutes and Service

Contracts, and for the cost of operation, depreciation, and repair of the district's sewer system including establishment and maintenance of working capital and reserves; and

WHEREAS, the above stated statutes and Service Contracts provide that the Authority may prescribe the amount to be charged for the discharge and disposal of sewage through the district sewer system pursuant to N.J.S.A. 14:14B-1, et seq. and related statutes thereto; and

WHEREAS, by Resolution dated November 3, 1983, the Commissioners determined that, commencing January 4, 1984, and for a period of three years, User Service Charges be calculated based upon a formula which gave equal weight in determining User Service Charges to adjusted metered flow, water connections based on equivalent dwelling units, and water usage; and

WHEREAS, the said Resolution further provided that, effective January 1, 1987, User Service Charges be calculated according to a formula in which 60% of User Service Charges are based on adjusted metered flow, 20% are based on water connections and 20% are based on water usage (the "60-20-20 Formula"); and

WHEREAS, the Commissioners of the Authority adopted Resolution No.49-2013 Amendment to the 2013 Annual Budget (the "Budget Amendment") in which Non-Operating Appropriations/Other Reserves were reduced by \$1,598,983 which has allowed the Authority to reduce the amount of Service Charges required by \$1,598,983.
